- One family hosted in July; next host week: October 12–19.
- Anna planning volunteer training in September/early October.
- Family Promise Capital Region 10th Anniversary this year; Doors to the Future fundraiser October 23 (honoring host/support congregations).

#### • Red Cross Blood Drive

- June & August drives exceeded goals; gratitude to parishioners.
- Next drive: October 13 (Columbus Day).

• Project underway to grow outreach to SMS homebound; 8 parishioners currently visit and bring Communion.

- Anna & Gloria compiling a brochure (ready this month) listing ministries at SMS & SGA with contacts/descriptions.
